Please note that the visits to (a) St. Clair County, Southwestern Illinois CC, and IYC – Pere Marquette (b) Pinckneyville and Big Muddy River CC; (c) Lawrence and Vandalia CC, and (d) IYC – Harrisburg and Murphysboro entail overnight travel.
