The schedule below lists visits to Illinois Department of Corrections and Illinois Department of Juvenile Justice facilities for the next several months. We urge you to join us on these monitoring visits. Please check those you plan to accompany and return a copy of this form to JHA or call or e-mail us as soon as possible. This schedule and any revisions will be posted on our website at www.john-howard.org

Visits to IDOC facilities generally begin at 10:00 a.m. unless otherwise specified. Please note that the paired visits to Logan and Lincoln correctional centers in March and Menard and Centralia correctional centers in April call for two consecutive overnight stays. Individuals are free to visit only one of the two paired prisons to minimize their time out of town.

The timing of visits to IDJJ facilities is established after the visitors are identified, but generally start between 9 and 10 a.m. The visit to the Cook County Juvenile Temporary Detention Center will begin at 9 a.m.
